Credit and debit card payments accepted through PayPal. Information is available at the Sand Sea & Spirit websites listed above. This fee is nonrefundable and helps to cover the following expenses: 2 conference rooms – 180 person and a 20 person which opens to pool area for social events and gathering area; Breakfast each day from 7-9 am (Protein shakes, bagels, muffins and eggs); Coffee, tea, etc. in the Social Room (smaller conference room); Scheduling of classes; Entertainment; Selected meals; Welcome bag with coupons; SSS Administrative costs, including Registration and Communication desks, printings, mailings, and a bevy of other expenses.

You may go online to check each condo using a November date to see pictures and availability as 25 condos will not show during the dates of Sept. 20-27 as Brett Robinson/Phoenix VII have reserved a block on 25 condos for our group during this time period to help assure space for our organization. This reserve block last up until 30 days prior to our scheduled arrival and will continue taking reservations as the stated rates, subject to availability, but to assure a space, please call as soon as possible.

Each Condo has a fully equipped kitchen, washer and dryer (no clothes soap or softener), an initial supply of paper product only are provided. Pool closes at 10 pm. Pricing is as follows: Sept. 20-27 (7 nights of SSS) 1BR: \$628.26    2BR: \$796.98    3BR: \$923.52. Extended dates for longer stay (10 nights) 1BR: \$891.33    2BR: \$1128.87    3 BR: \$1313.13. Stated condo fees include “all inclusive of all fees and taxes for the stay including cleaning before and after departure.” Check-in is anytime after 3pm, and check-out is anytime before 11 am. As you reserve your condos, an earnest money deposit by credit or debit card or check is required within 7 days of reservations as follows: 1BR: \$129.87    2BR: \$164.28    3 BR: \$193.14. The condo cancellation policy gives you until 7 days prior to arrival to cancel with only a \$25 per reservation fee. If you cancel within the 7 days of arrival, the entire deposit is forfeited.
